

RESOLUTION NO. 2014-02

A RESOLUTION APPOINTING POLICE CHIEF LLOYD MARTLEY AS THE CITY ADMINISTRATOR FOR THE CITY OF BASEHOR, KANSAS.

WHEREAS, pursuant to K.S.A. 15-301, the Mayor of Basehor is in charge of all affairs of the City of Basehor; and

WHEREAS, the Governing Body delegates many of these duties and affairs to a City Administrator; and

WHEREAS, the City currently is without a permanent City Administrator; and

WHEREAS, Police Chief Lloyd Martley currently serves as the Interim City Administrator; and

WHEREAS, the Governing Body wishes to appoint Chief Martley to be the City Administrator until it is determined that a separate, full time City Administrator should be hired.

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF BASEHOR, KANSAS:

Section 1. That Police Chief Lloyd Martley is appointed as the City Administrator, with all of the authority needed to fulfill such duties.

Section 2. That the Governing Body and Chief Martley agree that Chief Martley's first responsibility is to continue to be in charge of, and provide leadership to, the Basehor Police Department, and that his performance of City Administrator duties will not adversely affect the Governing Body's view of his performance as Police Chief. The Governing Body has determined that Chief Martley shall be the City Administrator, until it is determined that a separate, full time City Administrator should be hired. The City Administrator position and the Police Chief position are exclusive of each other, and a decision to make a change in one position will not impact the other.

Section 3. That Chief Martley's pay as City Administrator shall continue at the rate previously established for him as the Interim City Administrator, and shall be subject to cost of living and merit increases in accordance with the City's personnel policy. Because of the prior decision on pay and the nature of this action, the parties will not enter into an employment contract.

Section 4. That this resolution shall become effective upon passage.




