

ORDINANCE NO. 58

AN ORDINANCE RELATED TO AND PROVIDING FOR THE ANNEXATION OF CERTAIN LAND, TRACTS, LANDS, OR PIECES OF LAND, PLATTED AND UNPLATTED, TO THE CITY OF BASEHOR, AND DESCRIBING SUCH LAND, LANDS, AND/OR TRACTS OR PIECES OF LAND.

WHEREAS, the City of Basehor, Kansas, is a duly and legally constituted municipal corporation and a city of the third-class all under and by virtue of the laws of the State of Kansas, said City having a Mayor-Council form of City Government; and

WHEREAS, the Governing Body of said City deems it in the best interest of said City to enlarge the territory of the said City by annexation; and

WHEREAS, certain land and lands situated in Leavenworth County, Kansas, and more particularly described below complies with those statutory requirements set forth in K.S.A. 12-519, 1970 Supp. and K.S.A. 12-520, 1970 Supp. which empowers the City to annex same;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BASEHOR, KANSAS:

Section I: That the said land or lands and territory known and described as follows:

A tract in the Southwest Quarter (SW $\frac{1}{4}$) of Section Two (2), Township Eleven (11), Range Twenty-two (22) beginning at a point 3996.40 feet South and 830 feet West of the Southwest corner of the Southwest Quarter (SW $\frac{1}{4}$) thence North and South 446.50 feet by East and West 195.12 feet, all situated in Leavenworth County, Kansas;

A tract in the Southwest Quarter (SW $\frac{1}{4}$) of Section Two (2), Township Eleven (11), Range Twenty-two (22), beginning 3996.40 feet South and 1220.24 feet West of the Southwest corner of the Southwest Quarter (SW $\frac{1}{4}$), thence North and South 446.50 feet by East and West 195.12 feet, all situated in Leavenworth County, Kansas;

The middle 6.5 acres of the Northeast Quarter of the Southwest Quarter ($NE\frac{1}{4}SW\frac{1}{4}$) and the middle 13.5 acres of the Northwest Quarter of the Southeast Quarter ($NW\frac{1}{4}SE\frac{1}{4}$) of Section Two (2), Township Eleven (11), Range Twenty-two (22), all in Leavenworth County, Kansas, containing 17.764 acres; the South 6.5 acres of the Northeast Quarter of the Southwest Quarter ($NE\frac{1}{4}SW\frac{1}{4}$), and the South 13.5 acres of the Northwest Quarter of the Southeast Quarter ($NW\frac{1}{4}SE\frac{1}{4}$) of Section Two (2), Township Eleven (11), Range Twenty-two (22), all in Leavenworth County, Kansas, containing 20 acres; the North 6.5 acres of the East one-half of the Southeast Quarter of the Southwest Quarter ($E\frac{1}{2}SE\frac{1}{4}SW\frac{1}{4}$) and the North 13.5 acres of the Southwest Quarter of the Southeast Quarter ($SW\frac{1}{4}SE\frac{1}{4}$) of Section Two (2), Township Eleven (11), Range Twenty-two (22), all in Leavenworth County, Kansas, and containing 20 acres.

Section II: Upon passage and publication of this Ordinance the City Clerk shall file a certified copy of such Ordinance with the City Clerk, the Register of Deeds and the County Election Commissioner.

Section III: This Ordinance shall take effect and be in force from, after and upon its passage by this Governing Body and its publication in the official city newspaper of the City of Basehor, Kansas, to-wit:
