

AN ORDINANCE RELATED TO AND PROVIDING FOR THE ANNEXATION OF CERTAIN LAND, TRACTS, LANDS, OR PIECES OF LAND, PLATTED AND UNPLATTED, TO THE CITY OF BASEHOR, KANSAS, AND DESCRIBING SUCH LAND, LANDS, LAND OR TRACTS OR PIECES OF LAND.

WHEREAS, the City of Basehor, Kansas, is a duly and legally constituted municipal corporation and a city of the third-class all under and by virtue of the laws of the State of Kansas, said city having a Mayor-Council form of City Government; and

WHEREAS, the Governing Body of the City of Basehor deems it in the best interests of said City to enlarge the territory of the said City by annexation; and

WHEREAS, certain land and lands situated in Leavenworth County, Kansas, and more particularly described below complies with those statutory requirements set forth in K.S.A. 12-519 and K.S.A. 12-520 which empowers the City to annex same;

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BASEHOR, KANSAS:

Section I: That the said lands or land and territory known and described as follows:

The West One-half ($W\frac{1}{2}$) of the Southwest Quarter ($SW\frac{1}{4}$) of Section One (1), Township Eleven (11), Range Twenty-two (22) in Leavenworth County, Kansas, except the following tracts condemned by the State Highway Commission of the State of Kansas for state highway purposes in Case No. 22,173 in the District Court of Leavenworth County, Kansas:

Tract A: Beginning at the Southwest corner of said Section One (1), Township Eleven (11), Range Twenty-two (22); Thence North Eighty-one point one feet (81.1) thence in an easterly direction to a point on the East line of the West one-half of the Southwest Quarter ($W\frac{1}{2}SW\frac{1}{4}$) of said Section, eighty point four (80.4) feet north of the Southeast corner of said West Half of the Southwest Quarter ($W\frac{1}{2}SW\frac{1}{4}$); thence South eighty point four feet (80.4) to the South line of said Section; thence West along said Section Line to the place of beginning (2.45 acres more or less).

Tract B: One point one three acres (1.13) more or less for relocation of a side road eighty (80) feet in width, the center line of which is described as follows: Beginning at a point on the North right-of-way line of the proposed highway four hundred thirty feet (430) East of the West line of said Section One (1)

Township Eleven (11), Range Twenty-two (22);
thence in a northwest direction five hundred
sixty-five feet (565) more or less, to the
West line of said Section; thence North fifty
feet (50).

Section II: Upon passage and publication of this
Ordinance the City Clerk shall file a certified copy of such
Ordinance with the City Clerk, the Register of Deeds and the
County Election Commissioner.

Section III: This Ordinance shall take effect and be in
force from, after and upon its passage by the Governing Body
and its publication in the official city newspaper of the
City of Basehor, Kansas, to-wit: The Basehor Sentinel.
