

ORDINANCE 233

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN LAND
WITHIN THE LIMITS AND BOUNDARIES OF THE CITY OF BASEHOR,
KANSAS.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BASEHOR,
KANSAS:

Section 1.

That the following described land meeting one or more of the
conditions of annexation as prescribed by K.S.A. 15-520 is hereby
included and brought within the corporate limits of the City of
Basehor, Kansas, as requested by the owners by written petition,
to wit:

Part of the Southwest one-quarter of Section
26, Township 10 South, Range 22 East in the
City of Basehor, Leavenworth County, Kansas,
being more particularly described as follows:


Commencing at the Southwest corner of said
Southwest one-quarter; thence North 0° 00' 00"
East, along the West line of said Southwest
one-quarter, a distance of 990.00 feet to the
Southwest corner of Pin Oak Country Estates,
a subdivision in the City of Basehor,
Leavenworth County, Kansas; thence North 89°
38' 46" East, along a South line of said Pin
Oak Country Estates a distance of 350.00 feet
to the Point of Beginning, said point also
being the Southeast corner of Lot 1, Block 4
of said Pin Oak Country Estates; thence North
0° 00' 00" East, along the East line of said
Lot 1, a distance of 168.29 feet to the
Southwest corner of Lot 1, Block 3 of said Pin
Oak Country Estates; thence North 89° 35' 57"
East, along the South line of said Lot 1,
Block 3, a distance of 150.00 feet to the
Southeast corner of said Lot 1, Block 3;
thence North 0° 00' 00" East, along the East
line of said Lot 1, Block 3, a distance of
142.00 feet to the Southwest corner of Lot 3,
Block 3 in said Pin Oak Country Estates;
thence North 89° 35' 57" East, along the South
line of said Lot 3, a distance of 134.00 feet
to the Southeast corner of said Lot 3; thence
North 0° 00' 00" East, along the Easterly line
of said Pin Oak Country Estates, a distance of
142.00 feet to a point in the Southerly right-
of-way of Pin Oak Drive as platted in said Pin

Oak Country Estates; thence North 6° 50' 12" East along the Easterly line of said Pin Oak Country Estates, a distance of 50.40 feet to a point in the Northerly right-of-way of said Pin Oak Drive; thence North 0° 00' 00" East, along the Easterly line of said Pin Oak Country Estates, a distance of 488.00 feet to the Northeast corner of said Pin Oak Country Estates; thence North 89° 35' 57" East, a distance of 530.01 feet; thence South 0° 00' 01" East, a distance of 75.00 feet; thence South 24° 57' 16" East, a distance of 149.65 feet; thence South 14° 16' 12" East, a distance of 233.36 feet; thence South 10° 43' 26" East, a distance of 187.87 feet to a point of curvature; thence Southwesterly, along a curve to the left, which has a chord bearing of South 74° 07' 47" West, a radius of 500.00 feet, a central angle of 10° 17' 35", and a length of 89.82 feet; thence South 21° 01' 00" East, a distance of 165.20 feet; thence South 71° 44' 25" West, a distance of 88.00 feet; thence South 0° 00' 00" West, a distance of 162.95 feet; thence South 89° 38' 46" West, a distance of 865.01 feet to a Point of Beginning and containing 15.4501 acres more or less.

Section 2.

This ordinance shall take effect and be in force from and after its publication in the official City newspaper.
