

ORDINANCE NO. 317

AN ORDINANCE AUTHORIZING THE ACQUISITION OF LAND FOR A SEWAGE DISPOSAL WORKS SITE TOGETHER WITH ALL THINGS NECESSARY AND INCIDENTAL THERETO IN THE CITY OF BASEHOR, LEAVENWORTH COUNTY, KANSAS, TO BE PAID FOR BY THE ISSUANCE OF GENERAL OBLIGATION BONDS OF THE CITY IN AN AMOUNT NOT EXCEEDING \$200,000 UNDER THE AUTHORITY OF K.S.A. 12-631t AND ARTICLE 1 OF CHAPTER 10, K.S.A.

WHEREAS, the Governing Body of the City of Basehor, Leavenworth County, Kansas, (the "City") has the authority to provide one or more systems of disposal works for the purification of the sewage of the City or any part thereof, and to build, operate and maintain such disposal works; and

WHEREAS, the Governing Body of the City deems it necessary to acquire a site for the construction and installation of a sewage disposal plant together with all things necessary and incidental thereto to serve the City and its inhabitants; and

WHEREAS, the Governing Body of the City intends to finance the cost of such site acquisition by the issuance of general obligation bonds of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BASEHOR, LEAVENWORTH COUNTY, KANSAS:

Section 1. That the acquisition of a site or sites generally located in Section 34, Township 10 South, Range 22 East in Leavenworth County, Kansas, (the "Site") for the construction and installation of a sewage disposal plant to serve the City is hereby authorized and ordered to be done.

Section 2. That to provide funds to pay the cost of acquiring the Site, general obligation bonds of the City in an amount

not exceeding \$200,000 under the authority of K.S.A. 12-631t is hereby authorized to be issued. The City does hereby express its official intent to reimburse any expenditures made or obligations incurred by it subsequent to the date of this Resolution from the proceeds of its general obligation bonds.

Section 3. That the City is hereby authorized to issue Temporary Notes pursuant to K.S.A. 10-123 to provide funds to pay part of the costs of the improvements until bonds may be issued. That said Temporary Notes may be issued pursuant to a resolution duly adopted by the Governing Body of the City.

Section 4. That the Governing Body of the City is hereby authorized to receive bids and award a contract for the construction of said improvements.

Section 5. That the City both reasonably expects and intends to finance the costs of said improvements from the proceeds of general obligation bonds of the City. The City does hereby express its official intent to reimburse any expenditures made or obligations incurred by it subsequent to the date of this Resolution from the proceeds of its general obligation bonds in the estimated maximum principal amount of \$200,000.

Section 6. That this Ordinance shall take effect and be in force from and after its passage and approval and publication in the official city paper.
