

**ORDINANCE NO. 305**

**AN ORDINANCE AMENDING THE SEWER SERVICE CHARGES OF THE CITY OF BASEHOR, KANSAS TO BE EFFECTIVE JANUARY 1, 1997.**

**WHEREAS**, Article 2 of Chapter XV of the Ordinances of the City of Basehor, Kansas contain specific provisions for sewer service charges; and

**WHEREAS**, the City has determined that the sanitary sewer rates as they now exist are not adequate and should be increased; and

**WHEREAS**, it is in the best interest of the City and the residents and citizens of the City of Basehor that said sanitary sewer rates be increased effective January 1, 1997.

**BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BASEHOR, KANSAS:**

That Chapter XV Utilities of the Ordinances of the City of Basehor, Kansas, be amended by the following provision:

**Section 1:** Article 15-240 is hereby amended as follows:

SEWER SERVICE CHARGE. The monthly charge for sewer service shall be as follows:

- Class I - (One Person or Vacant) - \$6.80
- Class I-B (Senior Housing - 14 Single Units) - \$95.20
- Class II (2-5 Persons in household) - \$20.35
- Class III (6 or more persons in household) - \$30.55
- Class IV-A (Duplex w/one person) - \$6.80
- Class IV-B (Duplex w/2-5 persons) - \$20.35
- Class IV-C (Duplex w/6 or more persons) - \$30.55
- Class IV-D (Apartment/10 Single Units) - \$68.00
- Class IV-E (Apartments/4 Single Units) - \$27.20
- Class IV-F (Duplex- 2 units/2-5 persons) - \$40.70
- Class IV-I (Apartments - 3 Single Units) - \$20.40
- Class IV-J (3 Duplexes - 6 Units/2-5 persons) - \$122.10
- Class IX (Schools per building) - \$554.70
- Class V (Churches per building) - \$20.35
- Class VI (Commercial-Wholesale/Retail) - \$40.70

**Section 2:** All other provisions of the Article not amended herein shall remain the same and shall be in full force and effect from the date of the original adoption of said Article by the City of Basehor.
