



The meeting was delayed until 6:25 p.m due to lack of quorum.

At 6:25 p.m., Mayor Garcia called the special meeting to order announcing the purpose of discussing salary and benefit package for the city administrator position. He then requested a motion to convene into executive session for twenty minutes.

A motion was made by President Bonee and seconded by Councilmember Dysart to convene into executive session for thirty minutes for the purpose of discussing salary and benefit package for the city administrator position. Roll call vote was taken with all members voting in favor. Motion carried 4-0. (6:25 p.m.)

At 6:45 p.m, the Council reconvened back into regular session with Mayor Garcia requesting an additional twenty minutes in executive session to finalize discussions regarding salary and benefit package for the city administrator position.

A motion was made by Councilmember Sifford and seconded by Councilmember Dysart to convene into executive session for twenty minutes to finalize discussions regarding salary and benefit package for the city administrator position. Roll call vote was taken with all members voting in favor. Motion passed 5-0.

At 7:05 p.m., Council reconvened back into regular session. There were no formal decisions made in executive session. Meeting adjourned at 7:05 p.m.
