Mayor Chris Garcia opened the Appeal Hearing at 6:00 p.m. with all members present. He read aloud the special meeting notice and then asked for a motion to convene into executive session for up to thirty minutes.

***Item #1. Due Process Hearing at Request of Employee Slaughter***

A motion was made by Councilmember Thomas and seconded by Councilmember Sifford to convene into executive session for thirty minutes to address a Due Process Hearing as requested by employee Andrew Slaughter. Roll call vote was taken with all members voting in favor. Motion passed 5-0. (Terry Horner, Andrew Slaughter, Luke Harkins also attended the executive session.)

Mayor Garcia called the special meeting back to order at 6:31 p.m. announcing it would be necessary to convene back into executive session to finalize discussions.

A motion was made by Councilmember Sifford and seconded by Councilmember Thomas to convene into executive session for twenty minutes to finalize the Due Process Hearing. Roll call vote was taken with all members voting in favor. Motion passed 5-0.

Mayor Garcia called the special meeting back to order at 6:51 p.m.

***Item #2. Consider Action on Appeal.***

A motion was made by President Bonee and seconded by Councilmember Thomas to accept the Mayor's decision to terminate employee Andrew Slaughter. Roll call vote was taken with all members voting in favor. Motion passed 5-0.
