

REQUEST FOR SPECIAL COUNCIL MEETING AND EXECUTIVE SESSION


TO: Mayor Chris Garcia


- Item #1.** Discuss and possibly take action to authorize negotiations with applicant for the position of city administrator.

SPECIAL MEETING

Mayor Garcia called the Special Meeting to order at 6:40 p.m. immediately following the worksession. All members were present with the exception of Councilmember Keith Sifford. He read aloud the Request for Special Meeting noting the items to be discussed.

Item #1. Discuss and possibly take action to authorize negotiations with applicant for the position of city administrator.

Mayor Garcia requested a postponement of this item until Councilmember Sifford has recovered and is able to be present.

Item #2. Schedule Joint Work Session with Leavenworth County Commissioners, Leavenworth Courthouse.

Mayor Garcia asked about Council's availability for this meeting. He stated that he had requested the meeting to discuss several items of mutual concern. He reported that the County Commissioners had suggested the week of August 15. The meeting was then scheduled for *August 17th, 6:00 p.m., Leavenworth County Courthouse.*

Item #3. Re-schedule 2006 Budget Public Hearing for August 22, 2005, at 6:00 p.m.

Mayor Garcia reported that Tom Singleton, Auditor, had made some revisions to the budget proposal in the area of bonds/interest that would require publication and the planned hearing would need to be re-scheduled from August 15th to August 22nd. He stated that the newspaper would be notified to publish the changes.

Councilmember Hooker asked to refer back to Item #1. He said he would prefer not to postpone action on this item. A motion was made by Councilmember Thomas and seconded by Councilmember Hooker to convene into an Executive Session for up to 45 minutes to discuss applicants for the position of city administrator. All voted in favor. Motion carried 4-0. (7:50 p.m.)

At 8:35 p.m., Mayor Garcia called the Special Meeting back to order announcing that no formal decisions were made in Executive Session.

A motion was made by Councilmember Thomas and seconded by Councilmember Hooker to authorize the Mayor to begin negotiations with Applicant #3 for the position of city administrator. All voted in favor. Motion carried 4-0.

There being no further business to discuss, Mayor Garcia closed the Special Meeting at 8:36 p.m.
