Mayor Garcia called the special meeting to order announcing the purpose of the meeting was to interview city administrator applicant #14. He then requested a motion to convene into executive session for thirty-five minutes to conduct the interview.

A motion was made by Councilmember Thomas and seconded by Councilmember Sifford to convene into executive session for thirty-five minutes for the purpose of interviewing applicant #14 for the position of city administrator. Roll call vote was taken with all members voting in favor. Motion carried 5-0. (6:17 p.m.)

At 6:54 p.m. Mayor Garcia called the regular meeting back to order announcing it was necessary to convene back into executive session for an additional ten minutes to finalize the interview.

A motion was made by Councilmember Thomas and seconded by President Bonee to convene into executive session for an additional ten minutes for the purpose of finalizing the interview with applicant #14. Roll call vote was taken with all members voting in favor. Motion carried 5-0. (6:55 p.m.)

At 7:05 p.m, the regular meeting was called back to order by Mayor Garcia. The mayor requested an additional thirty-minute executive session.

A motion was made by President Bonee and seconded by Councilmember Sifford to convene into executive session for thirty minutes to discuss the interview with applicant #14. Roll call vote was taken with all members voting in favor. Motion passed 5-0. (7:06 p.m.)

At 7:37 p.m., Council reconvened back into regular session. Meeting adjourned at 7:35 p.m.
