

A CHARTER ORDINANCE EXEMPTING THE CITY OF BASEHOR, KANSAS, FROM SECTION 75-1120, K.S.A. 1988 SUPP., AND SECTION 75-1122, K.S.A. PROVIDING FOR A UNIFORM SYSTEM OF FISCAL PROCEDURES, ACCOUNTING AND REPORTING FOR MUNICIPALITIES AND FOR ANNUAL AUDITS OF CERTAIN MUNICIPALITIES.

Section 1.

The City of Basehor, Kansas by the power vested in it by Article 12, Section 5, of the constitution of the State of Kansas, hereby elects to exempt itself from and make inapplicable to it K.S.A., 1988 Supp., Section 75-1120, providing for a uniform system of fiscal procedure, accounting and reporting for municipalities, and K.S.A., Section 75-1122, providing for annual audits for certain municipalities, which statutory sections are applicable to this city, but which are not applicable uniformly to all cities.


Section 2.

This charter ordinance shall take effect sixty-one (61) days after its final publication, unless a sufficient petition for a referendum is filed and a referendum held on the ordinance as provided in Article 12, Section 5, subsection (c)(3) of the Constitution of Kansas in which case the ordinance shall become effective if approved by a majority of the electors voting thereon.


Passed by the governing body, not less than two-thirds of the members-elect voting in favor thereof, this 2nd day of October, 1989.




