City Staff Present in the meeting: City Administrator Leslee Rivarola, Deputy City Administrator Maddie Bouton, Planning & Zoning Director Jim Sherman, City Planner Alex Van Dyke, Municipal Services Director Gene Myracle and City Clerk Kathy Renn.

2025 City of Basehor Year in Review Video

Councilmember Sims moved to accept the consent agenda as presented and Councilmember Standiferd seconded. The motion passed unanimously, 5-0.

2. Resolution 2025-20 - A Resolution Approving Budget Amendments for Certain Funds as Authorized by Kansas Statutes Annotated

Councilmember Standiferd moved to open the public hearing at 6:58 pm for the 2025 budget amendments and Councilmember Sims seconded. The motion passed unanimously, 5-0.

No public comment on the 2025 budget amendments.

Councilmember Sims moved to close public hearing at 6:59 pm for the 2025 budget amendments and Councilmember Standiferd seconded. The motion passed unanimously, 5-0.

Councilmember Sims moved to approve Resolution 2025-20: A Resolution Approving Budget Amendments for Certain Funds as Authorized by Kansas Statutes Annotated and Councilmember Standiferd seconded. The motion passed unanimously, 5-0.

Councilmember Michael J. Roe recused himself from items #3 and #4.

3. An application for rezoning to R-2 Two-Family Residential for a parcel located on the north side of Evans Road, East of 166th Street

Councilmember Standiferd moved to remand this item back to the Planning Commission for further evaluation the application for rezoning to Two-Family Residential for a parcel located on the north side of Evans Road, East of 166th Street based upon additional review of the golden criteria. I would like the planning commission to give further consideration to the following: Conformance to the Comprehensive Plan, Suitability of Property for current zoning and hardship on the owner compared to relative gain and Councilmember Sims seconded. The motion passed unanimously, 4-0.

4. An application for rezoning to R-2 Two-Family Residential for a parcel located on the south side of State Ave., East of 166th Street

Councilmember Standiferd moved to approve the rezoning request to R-2 Two-Family Residential District for Ad Astra Basehor Property LLC Tract 1. In support of this motion I adopt by reference the Golden criteria evaluation contained in the Staff Report for this item and Councilmember Sims seconded. The motion passed unanimously, 4-0.

5. Ordinance No. 977 - An Ordinance Authorizing the Levy of A One– Half Percent (.50%) Citywide Retailer' Sales Tax and Related Matters

Councilmember Sims moved Move to approve Ordinance No. 977 – An Ordinance Authorizing the Levy of a One-Half Percent (0.50%) Citywide Retailers' Sales Tax and Related Matters and Councilmember McEnroe seconded. The motion passed unanimously 5-0.

6. City of Basehor Appointment to Leavenworth County Port Authority

Councilmember Sims moved Approve the Mayor's appointment of Councilmember Shari D. Standiferd as the City of Basehor's appointment to the Leavenworth County Port Authority Board and Councilmember McEnroe seconded. The motion passed unanimously 5-0.

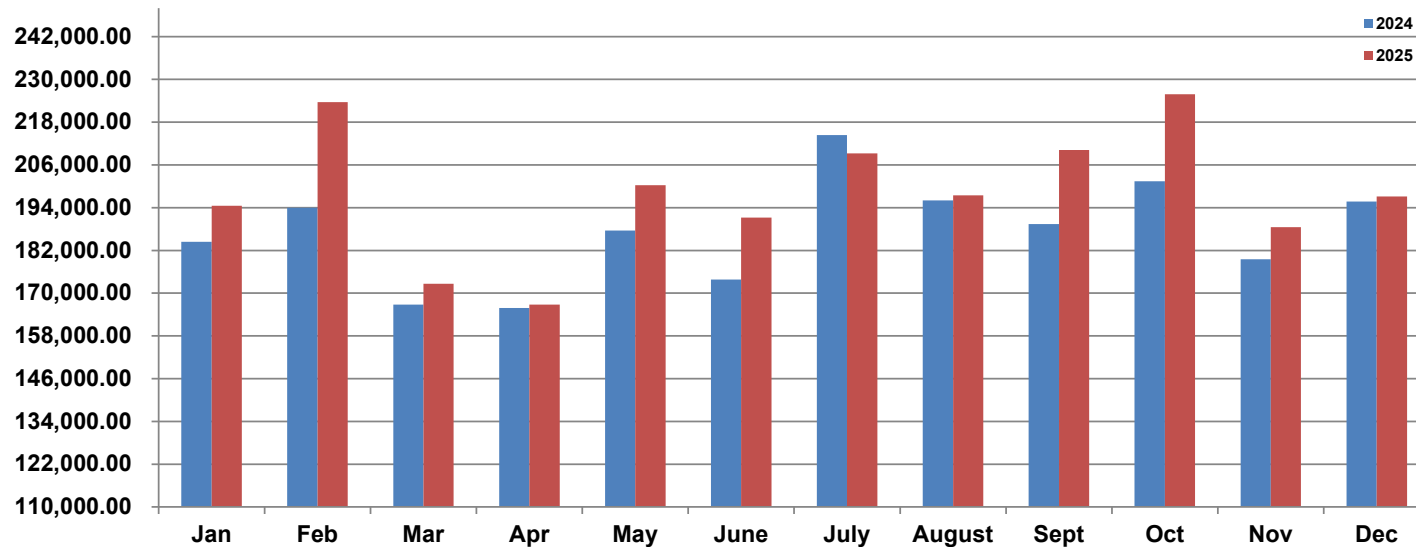

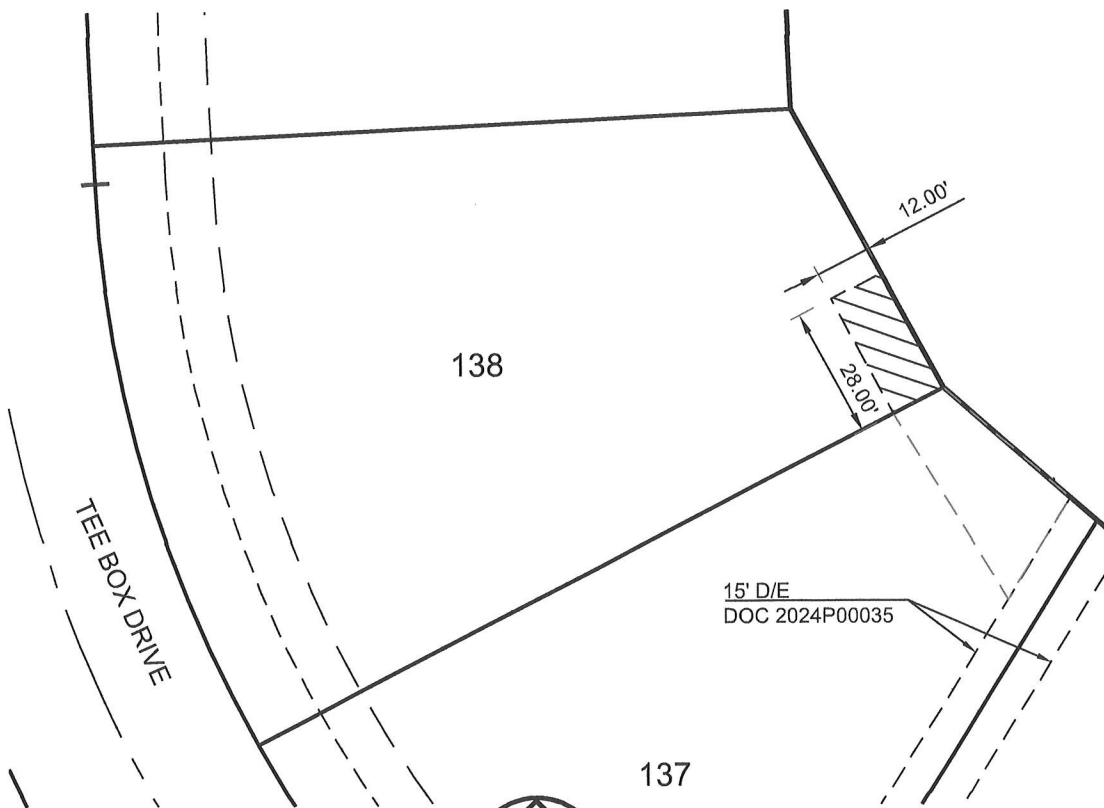

Rezoning from R-0 to R-2
PRZ-009-25 (Tract 2)

Proceedings on Remand:

The remand of planning matter PRZ-009-25 (Tract 2) was taken up by the Basehor Planning Commission on January 13, 2026 at 6:00 p.m.

City Planner Alex Van Dyke gave a brief staff report, including a description of the purpose of the remand of this matter by the City Council and the specific items for the Planning Commission to reconsider, which are:

- Conformance to the duly adopted Comprehensive Plan;
- The suitability of the property for the uses which it has been restricted; and
- The relative gain to the public health, safety and welfare by the destruction of the value of the petitioner's property as compared to the hardship imposed upon the individual landowners.

Mr. Van Dyke provided the position of City Staff on the foregoing items.

After discussion by the Planning Commissioners, Commissioner Lally moved to reverse the original recommendation of denial and recommend approval of planning matter PRZ-009-25 (Tract 2), rezoning from R-0 to R-2, adopting by reference the Golden factor analysis set forth in the staff report. The motion was seconded by Commissioner Tatkenhorst.

The motion was approved with a unanimous vote of the Planning Commission.

Recommendation on Remand:

The Planning Commission recommends approval of planning matter PRZ-009-25, rezoning from R-0 to R-2.
