**\*All actions forwarded from the Planning Commission on Public Hearing items will be submitted to Governing Body on the first Council Worksession meeting of the following month due to protest period requirements, no official action will be taken at this meeting.** City Council meetings are the first (1st) and third (3rd) Wednesday of each month.

Final Plats will not be forwarded to the Governing Body for acceptance of the dedication of public easements, right of way or parklands until the construction plans and any associated documents are approved by the City Engineer.
