The submittal dates for applications not requiring public hearings may vary depending on requirements of the Zoning and Subdivision Regulations, or in the absence thereof, at the Planning Directors

***All actions forwarded from the Planning Commission on Public Hearing items will be submitted to Governing Body on the first Council Worksession meeting of the following month due to protest period requirements, no official action will be taken at this meeting.** City Council meetings are the second (2nd) and fourth (4th) Wednesday of each month.

Final Plats may not be forwarded to the Governing Body for acceptance of the dedication of public easements, right of way or parklands until the construction plans and any associated documents are approved by the City Engineer.
